

## Waitlist Offer Terms and Conditions

1. By applying for Membership and registering to join the waitlist for Membership of South Australian Cricket Association Limited (ABN 44 623 135 393) (**SACA**), you agree to be bound by these terms and conditions and the SACA By-Laws (in particular by-laws 1.12, 1.13 and 1.14), [available here](#).
2. These terms and conditions apply in addition to SACA By-Laws 1.12, 1.13, 1.14 in respect of Membership applications, waitlist registration and Membership offers.
3. To register for the waitlist, you must have lodged an application for the relevant class of Membership in the prescribed form and pay, in full, the Waitlist Fee applicable at the time of registration, in accordance with SACA By-Law 1.12(b).
4. The waitlist and Membership Offers will be managed in accordance with SACA By-Laws 1.13 and 1.14.
5. Membership Offers will be subject to capacity, as determined at the discretion of the SACA Board from time to time.
6. **WAITLISTED APPLICANTS AGED 15 YEARS AND OVER (AS AT 01/09/2024).**
  - a. When an applicant's name has reached the top of the waitlist, they must either accept or reject the Membership Offer within the specified timeframe. No postponement option will be available.
  - b. If the applicant chooses not to accept the Membership Offer, their name will be removed from the waitlist. Prior standing and priority in the waitlist will be forfeited. A further Membership application will be required to re-join the waitlist.
7. **WAITLISTED APPLICANTS AGED UP TO 10-14 YEARS (AS AT 01/09/2024)**
  - a. Applicants aged 10 – 14 years of age that choose not to accept the Membership Offer will automatically be re-included in the waitlist and the applicant will receive a further Membership Offer at the age of 15. If the applicant wishes to accept a deferred Membership Offer before the age of 15, they can do so by contacting Membership Services within the SACA renewal period (i.e. mid-July to 31 October, unless notified otherwise).
8. SACA collects, stores, processes, uses, manages and discloses applicants' personal information in accordance with the SACA Privacy Policy [available here](#). By applying for Membership and registering for the waitlist and providing your personal information, you consent to the collection, storage, processing, use, management and disclosure of the personal information you disclose in accordance with the SACA Privacy Policy. The Privacy Policy (as updated and amended from time to time) will be deemed to form part of these terms and conditions. By providing your personal information, you:
  - a. confirm that you have been provided with an adequate opportunity to review and satisfy yourself of the terms of the SACA Privacy Policy;
  - b. consent to the inclusion of your personal information on SACA's, Cricket Australia's and the various other state and territory cricket associations' (**Other Cricket Associations**) mailing lists; and

- c. consent to SACA and Other Cricket Associations' use of your personal information to communicate directly with you to promote a product or service. The SACA Privacy Policy contains more details on how SACA uses your personal information for direct marketing including how you can opt out of direct marketing programs.
9. Capitalised terms have the same meaning as in the By-Laws.

### **Member Referral Promotion Terms and Conditions (limited time only)**

1. From **Friday 17 May 2024** (12.00pm ACST) until **Monday 3 June 2024** (11.59pm ACST) (**Promotional Period**) South Australian Cricket Association Limited (ABN 44 623 135 393) (**SACA**) is conducting a member referral promotion, as specified in these terms and conditions (**Promotion**).
2. By entering this Promotion, Referrers, Prospective New Members and New Members (as defined below) are deemed to have read, understood and agreed to these terms and conditions and the SACA By-Laws, [available here](#).
3. Subject to these terms and conditions, where an existing SACA Member (**Referrer**) refers to SACA a person who joins the SACA Membership waitlist and applies for Membership in accordance with SACA By-Laws 1.12 and 1.13, including by paying the prescribed Waitlist Fee, (**Prospective New Member**) the Referrer will be entitled to receive one (1) discount of \$20.00 for each Prospective New Member they refer, which may be redeemed and applied by the Referrer towards payment of the Referrer's Membership Subscription Fee for the 2024-25 Membership Year.
4. Subject to these terms and conditions, where a Prospective New Member is offered and accepts a Membership Offer for the 2024-25 Membership Year in accordance with SACA By-Laws 1.14(a) and (b), including by paying the Entrance Fee (if any) and Membership Subscription Fee prescribed for the relevant class of Membership, (**New Member**) the New Member will be entitled to receive one (1) discount of \$20.00 which may be redeemed and applied by the New Member towards payment of their Membership Subscription Fee for the 2024-25 Membership Year.
5. Each \$20.00 discount made available under this Promotion, whether to a Referrer or New Member, will be known as a **Referral Discount**.
6. For a Referrer to be eligible for a Referral Discount:
  - a. the Referrer must be a minimum of 18 years of age during the Promotional Period;
  - b. a Prospective New Member must not have held any Membership in the 2023-24 Membership Year;
  - c. a Prospective New Member must join the waitlist and apply for Membership as a result of the Referrer referring the Prospective New Member (**Referral**);
  - d. a Prospective New Member must apply to join the waitlist for Membership and pay the Waitlist Fee within the Promotional Period, using the portal available [here](#). A Prospective New Member must identify only one (1) Referrer in the relevant portal field(s). Details of the Referrer must be supplied in the portal at the time the application to join the waitlist is lodged and cannot be supplied at a later date or retrospectively;
  - e. a Prospective New Member is not required to receive or accept any Membership Offer or acquire Membership within the 2024-25 Membership

- Year (including such that a Prospective New Member does not need to meet the minimum Membership age of ten (10) years old); and
- f. the Referrer must hold a current financial Membership or receive a Membership Offer for the 2024-25 Membership Year that they subsequently accept, such that they will be a financial Member for the 2024-25 Membership Year. Persons holding honorary, non-financial or otherwise complimentary Membership will not be eligible to participate in the Promotion.
7. For a New Member to be eligible for a Referral Discount:
    - a. the New Member must not have held any Membership in the 2023-24 Membership Year;
    - b. the New Member must meet the minimum Membership age of ten (10) years old (any person under ten (10) years old is not eligible for a Membership Offer or for Membership);
    - c. the New Member must apply to join the waitlist for Membership and pay the Waitlist Fee within the Promotional Period, using the portal available [here](#). The New Member must identify only one (1) Referrer in the relevant portal field(s). Details of the Referrer must be supplied in the portal at the time the application to join the waitlist is lodged and cannot be supplied at a later date or retrospectively;
    - d. the New Member must join the waitlist and apply for and acquire Membership for the 2024-25 Membership Year as a result of the Referral;
    - e. the New Member must accept a Membership Offer for the 2024-25 Membership Year and pay the relevant Membership Subscription Fee prior to 31 October 2024 (or such other date as may be notified by SACA); and
    - f. both the Referrer and New Member must be eligible for the Promotion in accordance with these terms and conditions.
  8. A Referral Discount must be redeemed:
    - a. solely by the Referrer or New Member (as the case may be) and will not be in any way transferable;
    - b. solely for use for the 2024-25 Membership Year or it will otherwise be forfeited – no Referral Discount will be carried over to the 2025-26 or any subsequent Membership Year or be redeemable for cash;
    - c. against payment of the Membership Subscription Fee of the Referrer or New Member (as the case may be) for the 2024-25 Membership Year to reduce the fee otherwise payable by the amount of any Referral Discount – no Referral Discount may be:
      - i. applied against any Membership Subscription Fee for any other Membership Year;
      - ii. applied against any Entrance Fee or Absentee Fee for any Membership Year; or
      - iii. used in connection with any other Membership product, including without limitation any Transferable Associate Card, Guest Pass or Daily Seat Hold; and
    - d. at the time of paying the Referrer’s or New Member’s (as the case may be) applicable Membership Subscription Fee.
  9. A Referrer will be entitled to one (1) Referral Discount for each Prospective New Member Referral up to a maximum aggregate Referral Discount value equal to the

value of the Referrer's applicable Membership Subscription Fee for the 2024-25 Membership Year.

10. All monetary amounts stated in these terms and conditions are in Australian dollars.
11. SACA collects, stores, processes, uses, manages and discloses personal information in accordance with the SACA Privacy Policy available [here](#). By participating in this Promotion, and providing personal information to SACA, each Referrer, Prospective New Member and New Member consents to the collection, storage, processing, use, management and disclosure of their personal information they disclose in accordance with the SACA Privacy Policy. The Privacy Policy (as updated and amended from time to time) will be deemed to form part of these terms and conditions. The personal information which SACA collects through the Promotion portal is primarily used for the purposes of processing applications to join the waitlist and for Membership and SACA may use such personal information for the purposes of the Promotion and any matter connected with the Promotion.
