SACA Guidelines for Absentee

Clause 2.7 (a) of the Membership of SACA By-Laws states –

If a Member (excluding a SACA Big Bash Member):

- (i) anticipates being absent from the state of South Australia, for a full Membership Year; or
- (ii) through extenuating circumstances anticipates being unable to enjoy or require their Membership for a full Membership Year,

that Member may make a written application to SACA to have their name placed on the absentee list. SACA Big Bash Members are not eligible to apply to have their name placed on the absentee list.

Clause 2.7 (f) of the Membership of SACA By-Laws states –

Unless the Board determines otherwise, applications referred to in by-law 2.7(a) may only be made for one Membership Year at a time and no Member may have their name placed on the absentee list for more than three consecutive Membership Years.

As per Membership By-Law 2.7 (g) -

While a Member has their name on the absentee list, the following rights, benefits and privileges attached to the relevant Membership Class will be suspended:

- (i) the right of admission to Adelaide Oval or any other venue used or controlled by SACA;
- (ii) entitlement to the issue of a Member's Identification Card or any Transferable Associate Card or Reserved Seat Transferable Associate Card (as applicable); and
- (iii) the option to purchase any other benefits or privileges offered in relation to Membership.

Full, Country, Junior and Reserved Seat Members can apply to have their name placed on the absentee list. Placement on the absentee list has the effect of putting your Membership on hold for the 2025/26 season.

SACA Big Bash Members cannot apply to have their name placed on the absentee list.

To qualify for absentee status, the Member is required to be absent from South Australia for a full Membership Year (1 September 2025 to 31 August 2026) or must demonstrate extenuating circumstances, as detailed on the Absentee Application Form described above.

An Absentee Fee of \$105 applies (includes \$9.55 GST, as this is a taxable supply).

Applications are made annually.

To apply, complete an Absentee Application Form (and provide the required supporting documentation).

A late fee of \$50 will be charged for Absentee applications received and paid for after 12 September 2025 (includes \$4.55 GST, as this is a taxable supply). The Late Fee includes a contribution towards additional costs and expenses that SACA incurs in connection with the late processing of your absentee application.

Members on the absentee list will have most of their applicable Membership rights and benefits suspended for the period they remain on the absentee list, including but not limited to suspension of rights of entry to any Cricket Australia international and domestic matches at Adelaide Oval and Karen Rolton Oval, the right to purchase Transferable Associate Cards or Reserved Seat Transferable Associate Cards and Daily Guest Passes or to book for SACA Member hospitality and events.

Any Reserved Seat Member whose name is placed on the absentee list will forego and forfeit their reserved seat(s). The Member can reapply for Reserved Seat Membership in future seasons (subject to availability) however SACA cannot guarantee the Member's original assigned reserved seat(s) will still be available.

Members whose names are placed on the absentee list consent to be a Member of SACA and accept and agree to be bound by SACA's Constitution and By-Laws.

Absentee Members who have not paid their Absentee Fee by 11:59pm (ACDT) 31 October 2025 may have their Membership cancelled by the Board.

If your circumstances change, please inform SACA Member Services immediately.
