## SACA Membership Information

Membership of the South Australian Cricket Association allows you entry to all Cricket Australia international and domestic cricket matches played at Adelaide Oval including Test matches, One Day International matches, Twenty20 International matches, Sheffield Shield and Big Bash League matches.

Other privileges of being a SACA Member include:

- Access to Members' only facilities and seats in the western stand including the iconic SACA Village Green, plus exclusive facilities and seats in the Riverbank Stand Level 3 and sections of Level 5;
- The opportunity to book for exclusive Members' dining and other events;
- The opportunity to purchase a Transferable Associate Card each year for a guest to use throughout the season (subject to availability);
- The opportunity to purchase Daily Guest Passes and invite guests into the SACA Members' Area on selected match days;
- Reciprocal privileges at various prestigious interstate and international cricket venues, including the Lord's Cricket Ground in London;
- Free guided tours of Adelaide Oval; and,
- Nomination and voting rights for the SACA Board of Management elections and voting at SACA's Annual General Meeting.

The SACA Board of Management determines the number of people offered Membership in August of each year and the number varies from year to year. We are therefore unable to precisely determine the length of time you will be required to wait before you are offered Membership of the Association.

## SACA Waitlist Terms & Conditions

1. By applying for Membership and registering to join the waitlist, you agree to be bound by these terms and conditions and the SACA By-Laws (in particular by-laws 1.13, 1.14 and 1.15), available [here](#).
2. These terms and conditions apply in addition to SACA By-Laws 1.13, 1.14, 1.15 in respect of Membership applications, waitlist registration and Membership offers. Capitalised terms have the same meaning as in the By-Laws.
3. To register for the waitlist, you must have lodged a written application for the relevant class of membership in the prescribed form and pay, in full, the Waitlist Fee applicable at the time of registration, in accordance with SACA By-Law 1.13(b).
4. The waitlist and Membership Offers will be managed in accordance with SACA By-Laws 1.14 and 1.15.
5. Membership Offers will be subject to capacity, as determined at the discretion of the SACA Board from time to time.
6. WAITLISTED APPLICANTS AGED 15 YEARS AND OVER (AS AT 01/09/2025).
  - a. When an applicant's name has reached the top of the waitlist, they must either accept or reject the Membership Offer within the specified timeframe. No postponement option will be available.
  - b. If an applicant elects not to accept the Membership Offer, their name will be removed from the waitlist. Prior standing and priority in the waitlist will be forfeited. A further membership application will be required to re-join the waitlist.
7. WAITLISTED APPLICANTS AGED 10-14 YEARS (AS AT 01/09/2025)
  - a. Applicants aged 10 – 14 years of age who elect not to accept the Membership Offer will automatically be re-included on the waitlist and the applicant will receive a further offer upon reaching the age of 15. If the applicant wishes to take up the deferred offer prior to the age of 15, please contact Membership Services.
