Entry Requirements	Entry is only open to all Australian residents over eighteen (18) years old who have registered their child (or a child for whom they are legal guardian) who is between five (5) and ten (10) years old for a Woolworths Cricket Blast program through PlayHQ during the period 9.00am (ACDST) on Wednesday 19 November 2025 to 11.59pm (ACDST) on Sunday 30 November 2025 (Entry Requirements).
Ineligible Entrants	Staff/employees of SACA and Cricket Australia (and their immediate families) and any entities otherwise associated with running this Competition or administering any prize(s) are ineligible to enter (Ineligible Entrants).
Competition Period	The Competition is open from 9am (ACDST) on Wednesday 19 November 2025 and closes at 11.59pm (ACDST) on Sunday 30 November 2025 (Competition Period).
